On 8/25/2015 at approximately 2256 hours, I responded to Boulevard S at De Leon St W, in reference to assisting Officer Drumsta with a possible impaired driver.

Upon arrival, I observed a white in color Ford two door (the listed vehicle) as well as the driver, later positively identified via Florida Driver License to be Margo Land, who was seated in the driver seat. Also in the vehicle was Peter Hirons (W/M, DOB 7/26/1985).

I made contact with Officer Drumsta, who informed me of his observations thus far. Among those, Officer Drumsta stated that Margo Land was observed driving at a high rate of speed. Officer Drumsta advised he paced Margo Land with his patrol vehicle for several blocks and determined that she was traveling at 60mph in a posted 30mph zone. Officer Drumsta conducted a traffic stop on Margo Land and stated upon making contact with her, he observed that she had bloodshot/glassy eyes, slurred speech, and the odor of alcoholic beverages on her breath. See Officer Drumsta's supplement for further.

I made contact with Margo Land and informed her that I was requested to conduct a DUI investigation. Margo Land stated she was coming from Irish 31 and going home. Margo Land advised that she is not sick or injured, does not have any medical conditions or disabilities, is not suffering a diabetic episode, and is not having any mechanical issues with the vehicle. Margo Land admitted to consuming "three beers" and stated she doesn't take medication or use drugs.

While speaking with Margo Land, I smelled the distinct odor of an alcoholic beverage(s) emanating from her breath/body and she also had bloodshot/watery eyes as well as slurred speech. Margo Land also began crying and asked to exit the vehicle, which she did by exiting slowly and was unsteady upon immediately exiting.

All of the aforementioned indicated evidence of alcohol consumption and impairment; therefore, I asked Margo Land if I could look at her eyes and she stated that I could.

Exercise, I asked her if she had any disabilities or medical conditions relating to her eyes that would prevent her from following an object with her eyes and she stated she didn't. Margo Land also stated that she wears contacts, which she was currently wearing.

I explained the Horizontal Gaze Nystagmus Exercise to Margo Land and she stated she understood. Margo Land participated in the Horizontal Gaze Nystagmus Exercise at the location of the stop, facing south towards my patrol vehicle with the front emergency lights deactivated. During the Horizontal Gaze Nystagmus Exercise, I observed Margo Land to have lack of smooth pursuit in both the left and right eye, distinct and sustained Nystagmus at maximum deviation in both the left and right eye, and an onset of Nystagmus prior to forty five degrees in both the left and right eye (Margo Land's onset of Nystagmus was estimated to be thirty five degrees in both the left and right eye). Margo Land also had Vertical Gaze Nystagmus in both the left and right eye, swayed during the exercise, and had her arms lifted in the air to maintain balance.

Following the Horizontal Gaze Nystagmus Exercise, I asked Margo Land if she was willing to participate in the remaining Field Sobriety Exercises and she stated she would participate in them.I then asked Margo Land if she would remove her heels prior to participating in the exercises, which she did.

While removing her shoes, Margo Land inquired as to why she was being asked to participate in the Field Sobriety Exercises and I informed her they were to assist me in gauging her level of impairment.

Margo Land participated in the remaining Field Sobriety Exercises at the location of the stop. The outside lane marker was used, which was level and clear of debris. The Field Sobriety Exercises were explained and demonstrated for Margo Land and she stated she understood each exercise, prior to participating in them.

During the Walk and Turn Exercise, Margo Land lost her balance during instructions. During the first walking phase of the exercise, Margo Land was unsteady on her feet as she walked and took thirteen steps when she was instructed to take nine steps. Margo Land stopped and when asked, stated she didn't remember the instructions. I explained and demonstrated the exercise to Margo Land again and she again stated she understood. During the first walking phase of the exercise, Margo Land took a total of ten steps when she was instructed to take nine steps and made an improper turn by pivoting with both feet. During the second walking phase of the exercise, Margo Land missed heel to toe on step 5 and took a total of ten

steps when she was instructed to take nine steps. Margo Land also raised her arms for balance throughout the exercise.

During the One Leg Stand Exercise, Margo Land stood on her left leg and lifted her her leg. Margo Land swayed during the exercise and put her foot down. Margo Land also raised her arms for balance, lifted her foot above six inches, bent her legs and started several times before being instructed to do so.

During the Finger To Nose Exercise, Margo Land attempted to touch the tip of her nose with the tip of her finger, doing so in the following manner: bridge of nose/pad of finger on one (left), tip of nose/pad of finger on two (right), tip of nose/pad of finger on three (left), under nose/top of finger on four (right), wrong hand/tip of nose/pad of finger on five (right), and wrong hand/bridge of nose/pad of finger on six (left). During the exercise, Margo Land did not return her arms to her side on each attempt, opened her eyes, and initially started before being instructed to do so.

At this time, I placed Margo Land under arrest for driving under the influence (DUI) and sat her in the back of my patrol vehicle (#316). I asked Margo Land if she would provide a breath sample once we arrived at CBT and she stated she didn't want to provide a breath sample. I then read Margo Land Implied Consent (via form), which she stated she didn't understand. I then read Margo Land Implied Consent again and further explained it, to which she stated she understood and didn't want to provide a breath sample. Margo Land further stated she already provided a breath sample for me.

I verified Margo Land's information through NCIC/FCIC for wants or warrants and results were negative. I also confirmed through DAVID that Margo Land did not have previous convictions of DUI.

A rotation wrecker was requested and the vehicle was towed by South-Side Towing.

I later transported Margo Land to Central Breath Testing (CBT) where she refused to provide a breath sample. While at CBT, Margo Land was causing a disturbance by not following instructions and continuously getting up from her seat and yelling/being vulgar.

I escorted Margo Land to Central Booking prior to completing my paperwork, due to her behavior. While at Central Booking, Margo Land battered me by kicking me in my left groin area (TPD Case# 15-492143).
